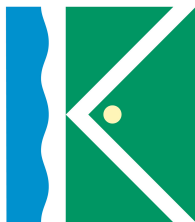

I further understand that each member of my family will hold separate membership in the Association and that annual dues will be charged in an amount deemed necessary by the Board of Directors for proper operation of the Association's facilities.

Following the Board's approval of my application and my acceptance of membership, I hereby agree to pay to Kanawha Recreation Association by the date set by the Board the Initiation Fee and Annual Dues then in effect. For the calendar year 2011, the Initiation Fee is \$2,000.00 and Annual Dues \$725.00. I understand the Board reviews these fees periodically and reserves the right to change them prior to the approval of my application. Furthermore, I understand each year the Board sets the amount of annual dues, and that as an active member I will be responsible for the current annual dues amount by the due date, both as communicated by the Treasurer. I understand the aforementioned fees will be used in conjunction with the programs of the Association and for the development and maintenance of its property.

This agreement is made by reason of my interest in the civic aims of the Association in providing supervised recreation facilities for its members and the community, and with the understanding that the operation of the facilities shall be under the control of the Board of Directors of the Association. I recognize that this agreement does not entitle me to any privileges with respect to these facilities until I am a member, and that privileges of the Association may not be granted to persons who do not make the required payments to the Association. I further understand that, from time to time, the Association may publish names, photographs and/or video clips of its members, for example in Association newsletters and on the Association's web site. In consideration of being granted membership in the Association, on behalf of myself and each minor child listed in the Application above, I irrevocably authorize the Association to use and publish our names and photographs in Association publications, including but not limited to Association newsletters and web sites.
